

# Beachcomber takes action to address the MV Wakashio environmental disaster

Ecology and the environment are a priority concern for Beachcomber. The Mauritian hotel group is monitoring very closely the situation arising from the oil leak caused by the MV Wakashio, which ran aground at Pointe d'Esny off the south-east coast of the island on 25 July 2020. A massive mobilisation has enabled the preservation of all beaches on the island and maintaining Shandrani Beachcomber's lagoon intact.

#### Solidarity above all

Recognising the environmental disaster caused, Beachcomber Resorts & Hotels has collaborated fully with the relevant authorities from the day of the MV Wakashio shipwreck in order to minimise its impact on the lagoon.

In a spirit of solidarity, the Group's Artisans have engaged with the environmental experts to limit the pollution spread.

# Beaches have been spared and Shandrani Beachcomber's lagoon preserved

The exceptional mobilisation of the Mauritian people and the work done by the experts have contributed to spare the island's beaches. Situated near the wreck site, Shandrani Beachcomber Resort & Spa was not affected by the spill. The beaches and Marine Park in Blue Bay are known for their exceptional fauna and flora. They have remained intact and have been preserved by the currents which carried the oil northward and the hard work expended by all the volunteers.

Amid the COVID-19 health crisis where the borders are still closed to tourists, Mauritius is being challenged with another disaster which can have a significant impact on the tourism sector and the economy at large.

Tourism is a pillar of the Mauritian economy and remains highly vulnerable to environmental disasters. Beachcomber fully understands this and since its inception, the hotel group has been striving to preserve the island's nature and beauty while consolidating its environmental approach through implementing best practices.

The Group has obtained EarthCheck Silver certification in 2019 for all its properties and drawn up an Environmental Charter with 52 commitments. It has also implemented the Safe Place certification building upon stringent cleanliness and hygiene standards to protect its guests and Artisans, but also to meet enhanced health, hygiene and safety expectations.
